As per existing criteria, the reservation in Science & Technology Department is applicable in post of Assistant Professor only, whereas, in the Department of Humanities & Social Sciences and Department of Management Studies reservation is applicable at all levels. Also, there is no fixed number of posts at various levels like Assistant Professor, Associate Professor, Professor and no fixed number of posts for Department of Humanities & Social Sciences and Department of Management Studies in each level.

In this connection requisite inputs in respect of IIT (ISM), Dhanbad is furnished below:

"IIT(ISM) Dhanbad is supporting teaching and research in the field of "Water Management and Conservation technology" with help of well-established departments like Department of Environmental Science and Engineering, Civil Engineering, Applied Geology, Applied Geophysics, Applied Chemistry and Chemical Engineering. These departments are running various UG/PG academic programs; organising seminars, conferences, training and workshops; publishing research papers, filing patents, and signing MoU with National and International organisations working in the field of "Water Management and Conservation technology" etc.

In 2020-21, IIT(ISM) Dhanbad has established the Centre for Water Resource Management (CWRM) to foster and forecast the studies related to "Water Security", a commitment given by the Government of India by 2030. The CWRM is working on the most burning research area i.e. delineation of the administrative boundaries of the rivers. In this connection, a "Concept Paper" has communicated with the Ministry of Jal Shakti to support the research. Further, the IIT(ISM) Dhanbad has become "Member Institute" with IIT Kanpur (Lead Institute) and suggested very important policy change for the restoration and conservation of the wholesomeness of the Ganga River Basin in different meetings organised by the Ministry of Jal Shakti and cGanga, IIT Kanpur. As a result, the Ganga River Basin Management Plan 2.0 (GRBMP 2.0) Framework is based on the (i) delineation of the administrative boundaries of rivers at local and regional scales in the Ganga River basin, (ii) restoration and conservations of rivers and their tributaries on the line IUCN RED DATA LIST and (iii) the interlinking of the forest cover at village, panchayat, taluka and district levels to save rivers and and aquifers.
