Under the collaborative doctoral program that was signed with one of the top ranked University-Curtin University and IIT(ISM) Dhanbad has provided the Joint Degree to the scholars and helped them in expanding their scope of work and opportunities across the globe.

Similarly in the Sandwich Ph.D. program students have the opportunity to get financial support/scholarship from the host country and it also provides them international exposure to the top universities.

Under the DAAD scheme the post graduate students (M.Tech) get good financial assistance from the German Government and they are allowed to spend one semester for which they get credit from the home institute.

Similarly, for the undergraduate's students Mitacs Internship provides exposure to them to visit academic institutions of Canada through scholarship.

Through the Erasmus+ program academic staff, faculty and students are benefited wherein there is exchange between the home and the host institute for a certain period related to academic research etc.

Yes there are MoUs signed between Government to Government as well. The list of some of the MoUs signed earlier are Ghana (ANU), Afghanistan (HeDP), and Ethiopia (MoSHE). MoUs are also signed with ONGC Videsh Limited, SII, and ICCR, ASEAN and AI-RTF etc. for the incoming mobility and exchange programmes of the students.

IIT(ISM) is also a member of the prestigious International Network like HERITAGE Network and members of the Consortiums like Consortium of Finnish Universities, Finland and Indo-French Consortium have been signed.

e. whether the Government has been working on a regulation that World-Class foreign Universities and Institutions have been allowed to offer courses in Financial Management, Science, Technology, Engineering etc. in the country; and if so, the details thereof?

The collaborations, research and academic, with different world class foreign institutes / universities / research organizations are governed under the policy guidelines of IIT(ISM), Dhanbad in line with the policies and principles of Ministry of Education and other Ministries of Govt. of India. The institute has framed its own guidelines for regulating all activities of international collaborations.

The incoming motilities of faculty from various universities across the world are funded by MoE under various schemes like GIAN and bilateral research projects and visiting faculties scheme in IIT(ISM) Dhanbad apart from various International conferences, workshops etc. Part-time or visiting Professors from different International Universities / Institutes in the areas of science, engineering and management are imparting courses, in full or partial, to the regular students of the Institute in UG and PG level.


