During presentation he stated that construction of Type V/VI quarters will be completed by the end of April 2020 and 1000 rooms boys hostel will be completed by September 2020.

The programme will be run jointly by Deptt. of Applied Geology and Applied Geophysics as detailed in the agenda item.

(i) Management of IIT (ISM) Shopping Centre

The broad guidelines for running of the Shopping Centre as recommended by a Committee was discussed by the Board. During the discussion, the Director made a point that in view of likely increase of student strength due to implementation of EWS quota, alternate priority usage of this infrastructure could also be explored, which was affirmed by the Board.
