Further, he admired Prof Shailendra Singh for being regular in attending the FC & BoG meetings and supporting the Institute with his valuable suggestions.

### 26/4 To review the Status Report of various ongoing construction works undertaken by CPWD and WEPCOS Ltd at IIT(ISM)

Shri Sanjeeb Mukherjee, Superintending Engineer, IIT (ISM), Dhnabad made a presentation on the status of ongoing construction works. The Board was informed that WAPCOS Ltd has awarded the work of construction of the boundary wall at Nirsa Land and the construction will start shortly. Besides, CPWD has completed 5 out of 6 major construction projects being undertaken by them. The Board appreciated the efforts of SE and his ECMU team for the same.

#### 26/5 Director's Report on the progress of various activities

The Director presented the performance of the Institute during the last three months and achievements made concerning various activities of the Institute. The same was noted by the Board. The Board deliberated that although, the Institute slipped in NIRF ranking but 25th QS ranking for the Mineral & Mining Department is remarkable. Other departments should also strive to achieve such positions and should benchmark with the Department of Mineral & Mining. The activities being carried out by the TexMin, NVCTI and ACIC in the field of innovation and patenting were appreciated.

# 26/6 Performance evaluation against the parameters of the MoU signed between IIT (ISM) Dhanbad and MoE

Prof. Dheeraj Kumar, Deputy Director, presented the performance of the Institute against each parameter of the MoU as on 31st March 2023. The Board expressed satisfaction over achievements with respect to targets fixed on several parameters. The Board further suggested setting targets on the higher side for parameters such as the teacher-student ratio should be 1:10 which is a norm for IIT System. The Board further advised the Institute to take the necessary steps to increase the NIRF ranking and it should be targeted in single digits and Institute should strive to achieve that.

#### 26/7 Ratification & Reporting Items

The BoG ratified the approvals accorded by the Chairperson, BoG, as mentioned in Sl. Nos. 1 to 12. Under the Reporting Items, Sl. No. 1 to 4 was also noted by the Board. Nomination of Prof. Dharmendra Kumar Singh, Director, BIT-Sindri as a member of the Board of Governors by the Government of Jharkhand was also noted by the Board. The Board also took a note that Prof. J K Pattanayak, Department of Management Studies and Industrial Engineering of IIT (ISM), Dhanbad has been appointed as the Officiating Director of the institute w.e.f. 01/07/2023 till such time as the regular incumbent takes over or till further order, whichever is earlier.

Tech in the relevant field has been relaxed as a one-time exception not to be cited as a precedent. Considering the above, the Board approved the proposal for appointment of Shri Manish Sinha as Professor of Practice in the Department of Mining Engineering.
