The Chairperson appreciated his sincere efforts in speeding up the faculty selection process, which was pending for various reasons.

The minutes of the 26<sup>th</sup> meeting of the BoG held on 30.06.2023 were circulated to all the members. The BoG, after deliberating the comments received from the JS (TE), MoE vide letter dated 19.07.2023, confirmed the minutes.

#### 27/2 Actions taken on the decisions of the 26th Meeting of the BoG held on 30.06.2023

Actions taken on the decisions made in the 26<sup>th</sup> meeting of the BoG held on 30.06.2023 were presented before the BoG. The BoG noted the implantation of eligibility criteria for the Professor of Practice (PoP) positions at IIT (ISM), Dhanbad, in line with the decision of the Council of IITs. The BoG further decided to hold its decision until the Ministry's concurrence is received. The Board of Governors noted the actions taken on other decisions.

		It was also suggested that the approved scope of work should not be changed midway. If at all, any major deviation in the scope of work is required, the same needs to be presented to the competent authority for approval of the revised scope of work. It was further informed to the Finance Committee that the selection of WAPCOS Ltd., the PMC, was done following the process laid down as per provisions of GFR 2017 and with the approval of the Finance	
		Committee and Board of Governors. The change of PMC from CPWD to WAPCOS was done due to the poor performance of CPWD in the execution of the infrastructure projects. Regarding the capability of WAPCOS Ltd. in executing large construction projects in educational institutions, the Finance Committee suggested obtaining the requisite information from WAPCOS about their past experience in executing similar works. After deliberations, the minutes have been confirmed

# 27/8 Signing of Memorandum of Understanding (MoU) between IIT (ISM), Dhanbad and Ministry of Education (MoE), Deptt. of Higher Education, Govt. of India

The draft Memorandum of Understanding (MoU) for the year 2023-2024 between IIT (ISM), Dhanbad and Ministry of Education (MoE), Deptt. of Higher Education, Govt. of India was presented before the BoG. The BoG deliberated on each parameter of the MoU and suggested to keep the target of Teacher-Student Ratio as 1:15 and strive to achieve the same. The BoG approved the draft MoU with the aforesaid modification and asked the Institute to send the signed copy of the MoU to MoE for further necessary action at their end.

## 27/9 To discuss the suggestions/comments given by the Expert Members regarding the Review of Departments of the Institute

Prof. Sagar Pal, Dean (R&D) gave a brief background of the Departmental Reviews conducted by an expert committee for each department having members from leading IITs/IISc to suggest possible suggestions for overall improvement of the departments. He also summarized the common observations and informed about the remedial measures already taken by the Institute. The BoG suggested that the NEP 2020 has the provision of Academic Bank of Credit (ABC) through which students can earn the academic credits after pursuing a course in any institute and get its credit transferred to other institute subject

To implement the same, the Institute needs to review and modify its existing course credits, course durations and grading systems to make it at par with other IITs and leading institutions so that ABC can be implemented for the benefit of students.
