Engagement of Visiting Ayurvedic Practitioner on visit basis in Health Centre at IIT(ISM), Dhanbad regarding.

The Indian Institute of Technology (Indian School of Mines), Dhanbad invites applications for engagement of Visiting Ayurvedic Practitioner on visit basis in Health Centre of the Institute for one year initially and renewable on year to year basis, subject to satisfactory performance to be evaluated by the Competent Authority till such time there is a felt need of such services or upto a maximum of 05 years, whichever is earlier. The details regarding eligibility criteria, terms of references etc. are as under:

Visiting Ayurvedic Practitioner on visit basis – 01 (one)

Essential Qualification:

- a) BAMS (Bachelor of Ayurveda Medicine and Surgery) or equivalent degree in Ayurveda from University or Institutions recognized by Central Council of Indian Medicine (CCIM).
- b) Retired Ayurvedic doctors from CGHS/ Central Govt. Research Councils/ State Govt./ Central or State Government corporations/ undertakings.

Failing which, the candidates who have completed compulsory internship and registered under the Central/ State Council of Ayurvedic Medicine with a minimum 03 Years of experience in reputed Hospital/Clinic.

Desirable

Candidates having relevant Post Graduate qualification in Clinical subjects.

Age Limit:

Preferably below 70 years of age.

Remuneration:

The Visiting Ayurvedic Practitioner will be paid a remuneration of Rs. 825/- per visit of two (02) hours. No other facility, allowances etc. shall be admissible.

Increment:

If the period of Contract is extended beyond one year, an annual increment of 5% on the remuneration per visit shall be admissible.

General Terms and Conditions:

- i. The engagement would be purely on visit basis for a period of one year initially subject to satisfactory performance, at the sole discretion of this Institute. Any claim for absorption at the regular position in the Institute will not be entertained at any point of time.
- ii. The period of engagement of Visiting Ayurvedic Practitioner shall be for a maximum period of 05 years subject of the age of 70 years.
- iii. The Institute may terminate the services of Visiting Ayurvedic Practitioner in case he/she is unable to perform their duty to the satisfaction of the Competent Authority without giving any notice and also without assigning any reason.
- iv. The Visiting Ayurvedic Practitioner shall have to attend Health Centre three days a week as per duties to be assigned by the Institute. However, working days may be increase on requirement basis.
- v. The Visiting Ayurvedic Practitioner may continue to draw pension and dearness relief on pension, if any, during the period of their engagement as Visiting Ayurvedic Practitioner. This engagement as Visiting Ayurvedic Practitioner shall not be considered as a case of re-employment.
- vi. No TA/DA shall be admissible to the Visiting Ayurvedic Practitioner for joining the assignment. Visiting Ayurvedic Practitioner will not be allowed any foreign travel at Institute's expenses. However, he/she may be allowed TA/DA for travel inside the country in connection with official work assigned to him/her.
- vii. The Headquarters of Visiting Ayurvedic Practitioner will be at Dhanbad.
- viii. Any resultant dispute shall be settled within the jurisdiction of Dhanbad.
