SUBMISSION OF FEES FOR MONSOON SEMESTER 2020-21 BY EXISTING (EXCEPT 3RD SEM. UG) STUDENTS

In continuation of the notices/emails sent to all the students regarding pre-registration, all existing students (except 3rd Semester UG students, who would be separately intimated about the time window to be followed by them) who have successfully pre-registered for Monsoon Semester 2020-21 are required to pay the requisite semester registration fees during **20 August 2020 to 15 September 2020** through **Parent portal**.

For **Tuition fee waiver** cases, as per the notice dated 11.06.2020 issued by Associate Dean (SIW), all students who have been provided tuition fee waiver in the last academic year (2019-20) will be provided tuition fee waiver (full or two third as the case may be) **provisionally** in this Academic year as an Interim measure. If there is any change in their eligibility status, as may be found later after the scrutiny/ verification of documents to be submitted by them in this regard, the difference in amount will be required to be paid by the student preferably before the registration for the next semester.

The fee payment through Education loan, where payment is directly made by the bank, can be credited to the Institute account no. 37052697697 (IFSC Code SBIN0001641) of State Bank of India, ISM Campus Branch, Dhanbad and the transaction detail of the payment must be sent by the student through email to Deputy Registrar (Finance & Accounts) at **feepayment@iitism.ac.in** with a copy of the email marked to **arug@iitism.ac.in** (for UG students), **arpg@iitism.ac.in** (for PG and PhD students). The fee payment receipt will be provided by return email. All such students are required to **upload their fee submission detail/receipt on the Parent portal** to complete their registration process.

All the students are advised to take a print out of their fee receipt and preserve it for future reference.

It may be noted that the process of pre-registration and payment of fees, as advised, are mandatory for continuity of students' registration for Monsoon Semester 2020-21. Failure in this regard will lead to cancellation of their semester registration.
