**NOTIFICATION**

**Subject: A ONE-TIME OPPORTUNITY IS GIVEN TO DELIVER THE RESEARCH PROPOSAL SEMINAR TO THOSE PH.D. SCHOLARS OF 2019 BATCH WHO HAVE CLEARED THE COMPREHENSIVE EXAMINATION BUT DID NOT DELIVER THE RESEARCH PROPOSAL SEMINAR WITHIN SPECIFIED DURATION.**

As per Clause 10D of the Ph.D. Manual, every Ph.D. scholar is required to deliver a Research Proposal Seminar on the area of the research before the DSC within **THREE MONTHS** from the date of clearing of the Comprehensive Examination. If any scholar could not deliver the Research Proposal Seminar within the specified period of three months due to some unavoidable circumstances, then on request of the scholar, **one-month** extension is given by the Dean (Academic) which is the maximum duration to deliver a Research Proposal Seminar. If a scholar fails to deliver the Research Proposal Seminar even after the extended period, the academic program of the scholar is terminated automatically.

It has been observed that the some of the Ph.D. scholars of 2019 batch have cleared the Comprehensive Examination with **SATISFACTORY GRADE** but did not deliver the Research Proposal Seminar within the specified duration.

It is notified that all the Ph.D. scholars listed below are required to deliver the Research Seminar Proposal before the date of commencement of the classes of the MS-2021-2022 *i.e.*, **16<sup>th</sup> August, 2021** and submit the report to the Office of the Dean (Academic), failing which the academic program of the scholar will be terminated automatically.
