NOTICE FOR UG STUDENTS REGISTERING IN 7th / 9th SEMESTER

Amendment in the Pre-registration guidelines related to registration of Backlog Courses (Applicable only for 2020-21 Monsoon Semester)

Please refer to the notice dated 13 July 2020 communicated by email from the office of Dean (Academic) indicating the Pre-Registration Schedule and Guidelines (Monsoon 2020-21) for UG students (Except 2019 Batch).

At present, the classes of 1st year and 2nd year are on hold and the date of commencement is uncertain owing to the present pandemic situation. However, the online classes of the 5th, 7th & 9th semester will start from 3rd August, 2020. The students who have pre-registered for the courses of 1st year and 2nd year may face difficulty in clearing the backlog courses on time. In addition, due to time table clash & maximum theory course limit, the students have to drop many current semester courses which will accumulate the number of backlogs. Therefore, certain changes in the notice dated 13 July 2020 are made to facilitate the students in clearing the regular semester courses.

In view of the above-cited issues and the present scenario, the following amendments are made in the existing Pre-registration guidelines related to registration of Backlog courses for UG students registering in 7^{th} / 9^{th} Semester for 2020-21 Monsoon Semester:

- (a) The condition given in the Pre-registration guidelines to register for the backlog courses of 1st, 2nd & 3rd semester has been relaxed for 2020-21 Monsoon semester.
- (b) However, the students having backlog courses of 5th and 7th semester will have to choose those courses first, if offered, and if there is no time table clash.
- (c) The registration link at the parent portal will be reopened for two days i.e., Monday, 27th July 2020 and Tuesday, 28th July 2020 for the following:
 - (i) The students (registered for backlog courses of 1st, 2nd & 3rd semester) must revise their registration form as per new guidelines.
 - (ii) The registered students must report discrepancy, if any, to reg_ug@iitism.ac.in by 30 July 2020.
 - (iii) Students who have missed the pre-registration must complete the pre-registration during 27-28 July 2020 failing which no excuse will be entertained and academic program of student will be terminated.

Please note that backlog courses of 1^{st} , 2^{nd} and 3^{rd} semester are being dropped for the time being only (till the commencement of 1^{st} and 2^{nd} year classes) in the larger interest of students. The modalities to clear backlog courses of 1^{st} , 2^{nd} & 3^{rd} semester will be informed in due course of time.
