NOTICE

Subject: - Submission of common application for Tuition fee waiver and Merit cum Means (MCM) Scholarship including free ship for the Academic Year 2020-21

Application, are invited from eligible students for Tuition Fee Waiver and Merit Cum Means Scholarship including free ship as under for the Academic Year 2020-21. :

Students Eligible for Tuition Fee Waiver : B. Tech. / Dual Degree / Integrated M. Tech. programmes admitted through JEE (Adv.)

Students eligible for Merit Cum Means Scholarship including free ship : B. Tech. / Dual Degree / Integrated M. Tech. programmes admitted through JEE (Adv.) up to 4th year, M.Sc. Tech, M.Sc, MBA.

Last date of submission of application (other than first year –newly admitted students of 2020-21 session) : June 30, 2020 (Single application will serve for both the scheme)

Note : ***Grade sheet is required to be submitted for MCM cum free ship - within a week after issue of even semester result.***

JEE admitted students of current session (2020-21) may apply at the time of admission for fee waiver and MCM Scholarship including freeship.

Other than JEE students to be admitted in current session (2020-21) are eligible only for MCM Scholarship including freeship and can apply within 15 days of their admission.

Eligibility Criteria: - Tuition fee waiver

1. Annual Family Income from all sources should not be more than Rs. 5,00,000/- (Rs. Five Lakh only) for availing Tuition Fee Waiver..
2. Annual Family Income includes income of both the parents (father and mother) and student from all sources. In case of death of any one parent, death certificate is necessary to be attached.
3. This scheme is not applicable for SC/ST/PWD students as they are exempted for payment of tuition fees.

4. Following documents need to be submitted to avail tuition fee waiver:

- a. Application in prescribed format in original duly signed by the student and both parents/guardian.
- b. Income Affidavit alongwith Schedule-A for statement of annual gross family income in the prescribed format duly *singed in the presence of Notary Public or a Magistrate/1st Class Magistrate Executive/ Revenue Officer (Tehsildar)/ who would also affix his / her signature and seal.* The Affidavit and Schedule-A for statement of annual gross family income in the prescribed format should be jointly signed by students and his /her parents.
- c. Family Income Certificate for the financial year 2019-20 (Assessment year 2020-21) duly signed by competent authority authorized by State Government in the format prescribed by Government. It is desirable that the family income certificate should not be signed by Notary Public in the form of Affidavit.
- d. Copies of detailed ITR for the financial year 2019-20 (Assessment Year 2020-21) of parents (Mother and Father) with copies of acknowledgements where the individual income exceeds the threshold limit as per Income Tax Rules.
- e. Aadhar Number of student and his/her parents is mandatory.

5. Rule for Tuition Fee waiver

- i. It is mandatory to submit the application in the prescribed format in original, duly signed by the students and the parents / guardian along with all required certificates / documents within the deadline
- ii. Income Tax Return (ITR) should be for the period 01.04.19 TO 31.03.20 i.e. Financial Year 2019-20 (Assessment Year 2020-21).
- iii. Income Certificate must be issued on or after 01.04.2020 and signed by the Competent Authority as per state govt. rules
- iv. The applications /documents received beyond the deadline will not be accepted and such claim will be summarily rejected. Therefore, the students are advised to get the documents prepared in advance to avoid any delay in submission of the applications along with the required documents
- v. There will be 100% tuition fee waiver, if annual family income is less than Rs. 1,00,000/- (Rs. One Lakh only) during the financial year 2019-20.
- vi. There will be 2/3rd tuition fee waiver, if annual family income is Rs. 1,00,000/- (Rs. One Lakh only) or above, but up to Rs. 5,00,000/- (Rs. Five Lakh only) during the financial year 2019-20.
- vii. There will be no tuition fee waiver, if annual family income is more than Rs. 5,00,000/- (Rs. Five Lakh only) during the financial year 2019-20.

i) Rules for Merit cum Means (MCM) Scholarship cum free ship

- i) While applying for Fee waiver students may or may not opt for MCM Scholarship cum free ship.
- ii) Eligible students : General and OBC Students admitted through JEE, / M.Sc. Tech/ M Sc and MBA students. (25% students will receive refund of tuition fee + Scholarship @ Rs. 1000/- pm) for 10 months and next 10 % students will receive only refund of tuition fee as per merit (year-wise), excluding the number of SC/ST students.
- iii) Income of the family should not be more than Rs. 6,00,000/- in the previous (last) financial year. Income Certificate must be issued on or after 1st April of Current financial year.
- iv) The merit criteria for awarding the MCM Scholarship to the B.Tech Integrated M.Tech, Dual Degree M.Sc.Tech, MBA students will be based on the OGPA 6.0 minimum obtained by the students up to the semester proceeding the semester in which the scholarship will be awarded. (Xerox copy of all semesters academic OGPA cards must be uploaded). For students having Summer / Special examination, minimum OGPA requirement is 7.00 out of 10. Students having disciplinary action against them will be debarred from award of Scholarship/Free ship.
- v) Merit of first year /newly admitted students will be based on IIT(JEE) rank and other Common merit list of entrance examination for the purpose of admission in IIT(ISM). These students must have obtained minimum 60% marks in the previous degree/course attended for making them eligible to appear in entrance exam.
- vi) Students qualified under this scheme will not be eligible for any other Scholarship.

ii) Following documents need to be submitted to avail Merit cum Means (MCM) Scholarship cum free ship . Apart from the documents mentioned in Fee waiver, other documents required are:

- i) Grade sheet / mark sheet last examination (even semester) passed.
 - ii) Copies of IIT(JEE) rank / common merit list rank for first year admitted students.
 - iii) Mark sheet of previous degree/course attended for making them eligible to appear in entrance exam.
- The complete application along with all required documents should be submitted/sent in original to the office of

DSW, IIT(ISM), Dhanbad - 826004 up to 30.06.2020. However, submission of grade sheet mentioned CGPA is required to be submitted within a week after release of even semester result. Applications received after the scheduled date will not be entertained. Incomplete application will not be considered.

All required documents (details as per attachment with this notice) must be attached with application.
