- 2. Candidates are advised to pay the above fee through online mode (SBI-Collect) only. Link of online payment is available on the institute's website. After successful payment bring the receipt of the same at the time of reporting.
- 3. The admission will be subject to fulfilling of eligibility criteria, submission of necessary documents in original. The candidates have to produce the following documents at the time admission:
 - a. Medical fitness certificate (in original) in the prescribed performa duly endorsed by Chief Medical Officer or equivalent of a government hospital as per the enclosed format.



- b. All relevant certificates (to be produced in original at the time of admission to the programme) related to academic qualification, date of birth as stated in the original application form.
- c. Original CAT 2017 Score Card and Admit Card.
- d. Migration certificate and/ or College Leaving Certificate issued by the University, original.
- e. One set of self-attested photocopies of all certificates.
- f. Four copies each of passport and stamp size photographs (same copy as was affixed on the application form).
- g. Caste certificate from appropriate issuing authority for SC/ST/OBC (Non Creamy Layer) candidates; certificates from the respective Record Office/Army Headquarters (Adjutant General's Branch) for Defence Personnel (DP) candidates in original.
- h. PwD must bring the Original Certificate issued by the Chief Medical Officer or equivalent of a government hospital.
- i. The OBC (Non Creamy Layer) candidates will be required to submit OBC (Non Creamy Layer) certificate as prescribed format as applicable for admission to Central Educational Institutions (CEIs) under Government of India (Annexure-2 attached) and should be issued by the officer not below the rank of District Magistrate/ Deputy Commissioner/ Competent Authority as indicated in the format attached. **OBC (Non-Creamy) certificate must be issued by the Competent Authority as per the attached format issued on or after January 01, 2018.**
- 4. The OBC (NC) candidates who have not submitted the OBC-NC certificate in proper format are required to submit a proper certificate as notified by competent authority issued on or after January 01, 2018 as per the enclosed format latest by May 14, 2108 (Monday) to the Head of the Department, Department of Management Studies, IIT (ISM), PO-ISM, Dhanbad-826004, Jharkhand by speed post/by hand. The candidate who fail to submit the certificate by due date will not be considered for admission in OBC-NC category.
- 5. If the result of the qualifying examination is not yet published, a certificate from the Head of the Institution/ College last attended mentioning that the candidate appeared in the qualifying examination and they will submit the certificate of passing the qualifying examination at Institute on or before September 30, 2018 (Sunday) positively. All original certificates including migration certificate must be produced by these candidates on or before September 30, 2018 (by 5.00 PM), failing which the provisional admission to MBA program shall stand cancelled without any further notice and there will be no refund of the fees in such cases.
