NOTICE FOR TUITION FEE WAIVER FOR JEE (ADVANCE 2018) ADMITTED STUDENTS

As per MHRD Govt. of India Notification F.No.24-2/2016 TS1 dated 8th April 2016 the students admitted from the academic year 2016-17 onwards through JEE (Advanced) are eligible for the following:

- g) The SC/ ST/ PH students shall get complete fee waiver.
- h) The most economically backward students (whose family income is less than Rs 1.00 Lakh per annum) shall get full remission of the fee.
- i) The other economically backward students (whose family income is between Rs. 1.00 Lakh to Rs. 5.00 Lakh per annum) shall get remission of 2/3rd of the tuition fee.


Accordingly, the JEE (Advanced) admitted students during 2018, sessions, eligible to avail Tuition Fee Waiver/Concession during 2018-19 academic year, are advised to submit their application in prescribed format (Annexure-I) along with Family income certificate (for the period 1.4.2017 to 31.3.2018) duly signed by Competent Authority to The Assistant Registrar (Examination & Academic), Indian Institute of Technology (Indian School of Mines) Dhanbad, Administrative Block, Dhanbad-826004. The last date for submission of application for tuition fee waiver (2018-19) is 10.08.2018.

It may also be noted that the Income Certificate submitted should have been issued by the Competent Authority as indicated in Annexure-II. In case of false certificate, the institute shall have full rights to take suitable action against student/ parent/ guardian, as the case may be. The delayed/ incomplete application will not be considered.

While submitting the application following points maybe noted:

- a) For fee waiver, **family income certificate** is required instead of individual income certificate.
- b) Those who cannot submit family income certificate may submit individual income certificate of parents (father and mother separately). Affidavit or copy of ITR only will not be considered as income proof. In case of zero income of any of the parent, the claim should be supported with appropriate document/certificate/verification.
- c) In case, where single parents is surviving, income certificate of survivor will be sufficient. In such cases the applicant has to submit death certificate/affidavit of the deceased.
- d) Name of father/mother/guardian on the family income certificate should match with the records of the institute.
- e) Family Income certificate must state the income for the financial year 2017-18 (1.4.2017 to 31.3.2018) and/or should be issued on or after 01.04.2018.

No further notice will be issued to those who have not qualified under the scheme and no further correspondence/request shall be entertained in this regard. All are requested to submit valid and appropriate documents for waiver of tuition fee.
