Sub: Application for ISMAANA Sponsored Scholarship for undergraduate students for the session 2017-18

- a. Manjit K. Gulati Memorial (MGM) scholarship (ISMAANA Sponsored) for an undergraduate student in Petroleum Engineering (US \$ 1000.00 Per Annum) (No. of Scholarships- 1)
- b. Pramod and Meera Thakur Trust (PMTT) scholarship (ISMAANA Sponsored) for an undergraduate student in Mining Engineering from the State of Bihar (US \$ 750.00 Per Annum for 2017-18 and US \$ 1000.00 Per Annum from 2018-19) (No. of Scholarships - 1)
- c. Srimati Sushila Devi Tuli Memorial (SDTM) scholarship (ISMAANA Sponsored) for an undergraduate student in Petroleum Engineering (US \$ 1000.00 Per Annum) (No. of Scholarships - 1)
- d. Dipak and Chitra Sarkar scholarship (ISMAANA Sponsored) for an undergraduate student of any branch of Engineering (US \$ 1000.00 Per Annum) (No. of Scholarships - 1)
- e. Zueb and Shera Mogri scholarship (ISMAANA Sponsored) for an undergraduate student in Applied Geology/ Applied Geophysics from the State of Gujarat or Maharashtra (US \$ 1200.00 Per Annum) (No. of Scholarships - 1)
- f. Chugh Family Foundation scholarship (ISMAANA Sponsored) for undergraduate students in any branch of Engineering (preferred for girl students of Punjab, Haryana or Delhi). (US \$ 1000.00 Per Annum each for first, second, third and fourth year student) (No. of Scholarships - 4)
- g. Peggy and Avinash Ahuja scholarship (ISMAANA Sponsored) for undergraduate students in any branch of Engineering. (US \$ 1000.00 Per Annum each to ten students, two in first year, two in second year, three in third year and three in fourth year) (No. of Scholarships - 10)
- h. Naresh Vashisht Foundation scholarship (ISMAANA Sponsored) for undergraduate students in any branch of Engineering. (US \$ 1000.00 Per Annum) (5 students each from 1st Yr, 2nd Yr, 3rd Yr and 4th Yr) (No. of Scholarships - 20)

1. The amount will be released in equivalent Indian Currency as per prevailing conversation rate.
2. The students will be selected for award of scholarship on a merit cum means (MCM) basis.
3. These scholarships will not be available to those students who are currently receiving any other scholarship. The students selected for one scholarship will not be eligible for other scholarship. Waiver or return of tuition fee to a student by IIT (ISM) is not considered as a scholarship for this purpose.
4. The family income of the student in the financial year 2016-17 / assessment year 2017-18 should not be more than Rs. 2.00 lakhs per year. The family includes parents/ guardian of the student. The income certificate issued by the authorized officer of the District Administration as indicated in the attached form should be submitted along with the application.



5. During 2017-18 academic year, the first year student of undergraduate courses (B Tech/ dual degree, Integrated M Tech) of respective discipline will be considered for award of scholarship on the basis of AIR Rank in JEE (Advance).
6. The scholarship will be discontinued for the selected candidate in case of change of branch from their respective discipline to other department or leaving the institute without completing the course. (**applicable for specific disciplined Scholarship**).
7. The student receiving the scholarship shall continue to receive the scholarship in succeeding years until graduation so long as the recipient maintains good academic standing based on assessment by the Deans Committee or student receives a more lucrative scholarship. A minimum grade point average of 7 out of 10 shall be considered to be good academic standing.
8. Once a scholarship recipient has graduated, a new first year student to be selected for that specific scholarship on MCM basis.
9. Once the scholarship recipient disqualifies for the scholarship, a new student from the same year to be selected for that specific scholarship on MCM basis.
10. The student should submit separate individual application as per his/her eligibility for ISMAANA scholarship(s). However, selection will be only for one scholarship. Any false information will lead to disqualify the candidate for future scholarship and lead to disciplinary action against the student.
11. The scholarship has been initiated by ISM Alumni Association of North America (ISMAANA). The release of scholarship amount will be subject to receipt of annual scholarship funds from ISMAANA to IIT (ISM).

Additional Criteria

- i.) **For scholarships to students belonging to particular state;** the student will require to submit their domicile certificate issued from Competent Authority of the concerned state.
- ii.) **For Zueb and Shera Mogri Scholarship,** during 2017-18 academic year, the first year student of Integrated M Tech Applied Geology in Applied Geology will be considered for award of scholarship. If such candidate is not found in Applied Geology then an student of Integrated M Tech Applied Geophysics will be considered based on AIR Rank in JEE (Advance).
- iii.) **For Chugh Family Foundation Scholarship,** the female students from Punjab/Haryana/Delhi will be preferred for the said scholarship. In case of non-availability of suitable girl student, the name of male students will be considered of the respective state. During 2017-18 academic year the first year student of B Tech/ Integrated / Dual Degree in any branch of Engineering will be considered for award of scholarship based on AIR Rank in JEE (Advance). Similarly the second year / third year / fourth year student will be selected based on CGPA of concerned students upto 2nd / 4th / 6th Semester CGPA

The eligible interested students may submit their application in prescribed format latest by 22.01.2018 by 4.00 PM in the office of the Dean (Student Welfare). Delayed/ incomplete application will not be considered and will be summarily rejected. In case of any doubt, the students may seek the clarification personally from the office of Dean (Student Welfare) during any working day.
