<u>Development of Online Application/Admission System for IIT(ISM) M. Tech./Ph.D.</u> <u>Programs Admission-2018</u>

The process of admission to M. Tech./JRF (Phase I and Phase II) program for the session 2018-19 in Indian Institute of Technology (Indian School of Mines) Dhanbad will start from 1st February 2018. Around 7000 applications are expected for the said programs.

In this connection, the admission committee requires the services of reputed Agencies having expertise and experience of at least five year immediately proceeding the current financial year.

Brief Description of Requirement

- Development and hosting of separate Web-link through the official website of the Indian Institute of Technology (Indian School of Mines), Dhanbad for online receipt of applications for M. Tech. and JRF Admissions – 2018. This link is to be kept for the entire process of admission. An e-application must also have provision for uploading of Photograph, Signature and Documents of the applicant.
- 2. Online verification of e-applications vis-à-vis essential requirements i.e., Age, Educational Qualification, Category, Fee, Eligibility etc. with reference to the advertisement instructions given in information brochure. The online application shall not be completed unless necessary checkpoints are exercised for Age, Educational Qualification, Category, Fee, Eligibility etc.
- 3. By using a combination of one E-mail ID and one mobile number, only one registration should be allowed on the online portal.
- 4. Providing link for downloading Admit Cards, Result, offer letter for provisional admission and other relevant information provided by the Admission committees from time to time to the applicants within the login of candidate.
- 5. Providing information to applicants through SMS and Email alerts for downloading admit cards and other communications, if any.
- 6. Arrangements for online submission of requisite fees through online banking / Debit card / Credit card etc. In case of failure of payment, the refund should be automatic.
- 7. Provisions of segregation of applications as per the requirements and instructions given by Admission committee.
- 8. (a) Allotment of Roll Numbers as per the instruction given by the Admission committee.
 - (b) Uploading of Admit cards.
 - (c) Generation of Attendance Sheets for examination centers for all the eligible applicants.
