Material: -

The mat must be made of a material with an impact absorption rate which complies with the WKF regulations, to protect the contestants if they fall. The pieces forming the mat must have two different sides: they must be non-slip on the side in contact with the floor and the upper side must have a friction rate that is compliant with the WKF regulations in order not to provoke excessive friction that may cause injuries and, at the same time, to avoid the contestants from sliding.
