Technical Specification of Basketball Pole

1. Basketball poles (up rights) Double channel size 200 x 75 making a box 200 x 150 with 3.2 mtr. Latest rules with projection of square pipe on all four corners of the boards.
2. Back boards – 30mm back board (Transparent Acrylic), 180 x 105 x 3 cms.(30) with International standard frame, Double Die frame of Aluminum Anodized/Steel power coated with built in brackets for mounting(for minor adjustments).
3. Pressure release rims/dunking rims – with three springs concealed mechanism (with inbuilt minor level adjustment mechanism). **Complete Die made, power coated as per International standard.**
4. **Dunk in Ring & Net.**
5. Protective padding for basketball poles and lower edges of board.
6. Finished with international standard power coated doe made frame with mounting.
