A. Solid state Generator: Solid state Generator conditions the incoming power suitable to operate induction forging. The incoming three- phase supply at 50 Hz is converted into DC using a bridge rectifier. The DC supply is converted to a single phase AC at required frequency using IGBT based inverter. The generator consist of DC smoothing protection circuits, a set of fault indication lamps, meters, push buttons, interconnecting bus bars, flow monitoring switch and conductivity meter for monitoring conductivity of de-ionized water. All these components are fitted into a dust proof MS cubicle.	
B. Water circulation system: Components of solid state generator, medium frequency capacity and interconnecting bus bars are cooled by water. Water is used for cooling various components in a close loop. Occasional make-up of this water is required.
