 B. Tech. / Dual Degree / Integrated M. Tech. Programmes admitted through JEE (Advance)

Students eligible for Merit Cum Means (MCM) Scholarship including Free-ship:
 B. Tech. / Dual Degree / Integrated M. Tech. Programmes admitted through JEE (Advance) up to 4th year, M.Sc. Tech, M.Sc, M.A. and MBA.

Last date of submission of application by post only (other than first-year newly admitted students of session 2024-25):

July 31, 2024 (Single application will serve for both the scheme as per option mentioned by students)

JEE (Advance) admitted students of current session (2024-25) may apply at the time of admission for fee waiver and MCM Scholarship including free ship. Separate notice will be issued for them just after their admission.

Other than JEE (Advance) admitted students of current session (2024-25) who are eligible only for MCM Scholarship including free-ship and can apply within 30 days of their admission.

It is mandatory to fill Google form (Google link will also be shared on mail) before the last date and submit your application in Hard Copy BY POST ONLY. Application through e-mails will not be entertained.

Eligibility Criteria:

A. Tuition Fee Waiver (TFW)

- 1. Annual Family Income (Gross, before any deduction/ exemption under the provisions of income tax, etc.) from all sources should not be more than Rs. 5, 00,000/- (Rs. Five Lakh only) for availing Tuition Fee Waiver.
- 2. Annual Family Income includes income of the parents (Father & Mother) and student from all sources. In case of the death of any one parent, the death certificate is necessary to be attached.
- 3. In case of separation of parents Necessary documents to this effect are also required.
- 4. This scheme is not applicable for SC/ST/PWD students as they are exempted from payment of tuition fees.
- 5. The following documents need to be submitted to avail tuition fee waiver: (Please read carefully):
 - a) Original Application Form in the prescribed format duly signed by the student and both parents/guardians.
 - b) Income Affidavit along with Schedule-A for statement of annual gross family income in the prescribed format duly signed in the presence of Notary Public or a Magistrate/1st Class Magistrate Executive/ Revenue Officer (Tehsildar)/ who would also affix his / her signature and seal. The Affidavit and Schedule-A for a statement of annual gross family income in the prescribed format should be jointly signed by students and his /her parents. All the columns of the forms must be filled even if it is NIL, otherwise the application may be rejected.
 - c) Family Income Certificate for the **financial year 2023-24** (Assessment year 2024-25) duly signed by competent authority authorized by State Government in the format prescribed by State Government. It is compulsory that the family income certificate should not be signed by Notary Public/ Chartered Accountants in the form of an Affidavit.
 - d) Copies of detailed ITR Computation for the financial year (F.Y.) 2023-24 (Assessment Year (A.Y) 2024-25) of parents (Mother and Father) with Verified copies of acknowledgments, where the gross taxable income before any deduction under any provisions exceeds the threshold limit of Rs. 2.50 lakbs.
 - e) Aadhar Numbers of student and his/her parents are mandatory. (enclose the Aadhar documents).



6. Rules for Tuition Fee waiver (TFW)

a) It is mandatory to submit the application in the prescribed format in original, duly signed by the students and the parents/guardian along with all required certificates/documents within the deadline.

b) Income Tax Return (ITR) should be for the period 01.04.2023 to 31.03.2024 i.e. Financial Year (F.Y) 2023-24

(Assessment Year (A.Y) 2024-25).

c) Income Certificate must be issued on or after 01.04.2024 and signed by the Competent Authority as per state govt. rules & regulations as per the annexure enclosed.

d) The applications /documents received beyond the deadline will not be accepted and such claims will be summarily rejected. Therefore, the students are advised to get the documents prepared in advance to avoid any delay in the submission of the applications along with the required documents

e) There will be 100% tuition fee waiver, if annual family income is less than Rs. 1, 00,000/- (Rs. One Lakh only)

during the financial year 2023-24.

f) There will be 2/3rd tuition fee waiver, if annual family income is Rs. 1, 00,000/- (Rs. One Lakh only) or above, but up to Rs. 5, 00,000/- (Rs. Five Lakh only) during the financial year 2023-24.

g) There will be no tuition fee waiver, if annual family income is more than Rs. 5,00,000/- (Rs. Five Lakh only) during the financial year 2023-24.

B. Merit Cum Means (MCM) Scholarship including freeship

- 1. Annual Family Income (Gross, before any deduction/ exemption under the provisions of income tax, etc.) from all sources should not be more than Rs. 6,00,000/- (Rs. Six Lakh only) for availing Merit Cum Means (MCM) Scholarship including free-ship.

- 3. In case of separation of parents Necessary documents to this effect are also required.

- 5. Rules for Merit cum Means (MCM) Scholarship cum free ship
 - a) While applying for Fee waiver students may or may not opt for MCM Scholarship cum free ship.
 - b) Eligible students: General, OBC, EWS, EBC Students admitted through JEE / M.Sc. Tech/ M.Sc. / M.A. and MBA students. (25% students will receive refund of tuition fee + Scholarship @ Rs. 1000/- pm) for 10 months and next 10 % students will receive only refund of tuition fee as per merit (year-wise).
 - c) Gross Income of the family should not be more than Rs. 6, 00,000/- in the previous (last) financial year 2023-24. Income Certificate must be issued on or after 1st April of Current financial year, i.e. On or after 01.04.2024.
 - d) The merit criteria for awarding the MCM Scholarship to the B.Tech Integrated M.Tech, Dual Degree M.Sc.Tech, M.A. and MBA students will be based on the CGPA 6.0 out of 10 grade points obtained by the students up to the semester proceeding the current year semester for which the scholarship will be awarded. (Self-attested Xerox copy of all CGPA cards must be submitted). For students having summer / Special examination, minimum CGPA requirement is 7.00 out of 10 grade points. Students having disciplinary action against them will be debarred from award of MCM Scholarship/Free ship.
 - e) Merit of first year /newly admitted students will be based on IIT (JEE) rank and other Common merit list / JAM ranking of entrance examination for the purpose of admission in IIT(ISM). These students must have obtained minimum 60% marks in their previous degree/course attended for making them eligible to appear in entrance
 - f) Students qualified under this scheme will not be eligible for any other Scholarship. If they apply any other scholarship will be debarred from MCM cum Free-ship.
- 6. The following documents need to be submitted to avail Merit cum Means (MCM) Scholarship cum free ship Apart from the documents mentioned in Fee waiver, other documents required are:
 - Grade sheet / mark sheet of last examination (even semester) passed. (i)
 - Copies of IIT (JEE) rank / common merit list rank for first year admitted students. (ii)
 - Mark sheet of previous degree/course attended for making them eligible to appear in entrance exam. (iii)
